

FIXED FEE DIVORCES

The average legal costs for an uncontested divorce in the Gauteng region amounts to R15 500.00. Often, these costs are increased to cater for additional disbursements such as sheriff fees and advocate fees. So there is a good likelihood that you, as a potential divorcee, will be required to pay in excess of R20 000.00 for a divorce, even if your partner does not dispute anything in the divorce.
